The 2023-24 Competitive Season is among us and we are honored and excited to experience it together. As a member of the Xcel Bronze through Level 10 Team program it is during the competitive season that our athletes are given the opportunity to display their efforts and commitment to the sport on a local, state-wide, and regional platform!

As you review this competition calendar and pricing agreement you will need to choose either a "Yes" or "No" for their participation status in each individual Meet. In addition, familiarize yourself with the listed policies.

Team gymnasts must have an active membership with USA Gymnastics. Your gymnast's member ID will be required information needed by Apollo in order to enter them into a competition. This requirement will create a unique deadline where a membership is due on or before the first Apollo registration deadline of the first participating Meet. Fees are due by the designated due date and can be paid in installments prior to the due date. All pre-payments must be processed with either Mr. Jacob (officemanager@apollogymnastics.com) or Ms. Lola (Lola@apollogymnastics.com).

Regarding the August 15th Magical Classic Meet deadline, accounts will only reflect a draft of the Coaches' Fee. All participating gymnasts have already processed their Entry Fee.

The competition fees will be automatically processed to the primary credit card registered in our system. If you would like to have our staff use an alternate card for the competition payments, you may do so by adding the preferred payment method to your Parent Portal account and follow up with an email to frontdesk@apollogymnastics.com confirming the last 4 digits of the card to be used. This communication must be received on or before the day PRIOR to the due date. On the registration due date, Apollo Staff will not accept communication for the use of alternate payments.

The Coaches' Fee are mandatory and will be automatically processed for all athletes regardless of the participation status. The Coaches' Fee is not dependent on how many competitions your athlete is registered for and must be paid in full for all competitions. The exception is Magical Classic for Xcel Bronze and Xcel Silver athletes only.

Apollo staff will automatically process the fees for each competition on the due date. The amount drafted will include both the Coaches' Fee and the Entry Fee if you selected a "Yes" participation status for the individual competition. The amount drafted will only reflect the Coaches' Fee if you selected a "No" participation status for the individual competition. It is encouraged that you request or retain a copy of the payment draft dates for your record. The Apollo facility will not send out reminder messages via text or email.

At the time of the competition if your account is reflecting a past-due balance on the monthly (Term) team tuition, your child will forfeit their ability to participate in the registered competition and will enter a 'scratch' status. Therefore, it is very important your account remains up to date.

In the event you decide to remove your child from the Apollo Team program, and for any reason, medical or non-medical, you hereby authorize Apollo School of Gymnastics to draft any and all remaining shared expenses, specified as the Coaches' Fee. This payment will be drafted in full and will occur on the day your Notice of Discontinuance is received, bypassing any aforementioned calendar draft date that may not have yet occurred.

Apollo staff will not bypass an outstanding charge(s) to process an Entry Fee. With any present outstanding charges, please familiarize yourself with the following procedure: If you have selected a "Yes" participation status, and have a past due balance, our staff will attempt to process your payment along with all outstanding charge(s). If it is past the registration deadline, these attempts will not include the Entry Fee. However, we will continue draft attempts in order to satisfy the Coaches' Fees along with the balance. Subsequently, your child will not be entered into the competition. Our staff will send out a text and an email to communicate the status change.

Due to the fact that competitions are scheduled events, entry deadlines cannot be extended.

If your child incurs an injury or experiences a medical condition where they are no longer able to participate in a Meet, Apollo will contact the host facility to see if the Entry Fee is refundable. The outcome will depend solely on the host facility's discretion. Additionally, all competitions have a unique deadline that marks the ineligibility of reversing Entry Fees. The Apollo Coaches' Fee are not eligible for a refund or credit.

Regional Team Fee / Coaching Expenses Shared :: *Qualifications for the Xcel Gold, Xcel Platinum, Xcel Diamond, and Levels 6-7-8-9 Regional Championships are determined during the State Championship. Regional Team Fees have not yet been determined. The Regional Team Fees will be calculated and divided by only the attending athletes that qualify. The Regional Team Fees will be due April 1st, 2024 (Levels 9 and 10), April 15, 2024 (Levels 6, 7, and 8), and May 1st, 2024 (Xcel).
